

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.sojourncc.com and Sojourn Community Church of the Christian & Missionary Alliance and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Sojourn Community Church of the Christian & Missionary Alliance include www.sojourncc.com, Sojourn Community Church, AKA Sojourn Productions, AKA Sojourn, and www.sojournprod.com. The Sojourn Community Church, AKA Sojourn Productions, AKA Sojourn website is a Ministry site. By using the Sojourn Community Church, AKA Sojourn Productions, AKA Sojourn website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, Sojourn Community Church, AKA Sojourn Productions, AKA Sojourn may collect personally identifiable information, such as:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. Sharing Information with Third Parties

Sojourn Community Church, AKA Sojourn Productions, AKA Sojourn does not sell, rent or lease its customer lists (including mobile number) to third parties.

Sojourn Community Church, AKA Sojourn Productions, AKA Sojourn may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Sojourn Community Church, AKA Sojourn Productions, AKA Sojourn, and they are required to maintain the confidentiality of your information. No mobile information will be shared with third parties/affiliates for marketing/promotional purposes. All the above categories exclude text messaging originator opt-in data and consent; this information will not be shared with any third parties.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by Sojourn Community Church, AKA Sojourn Productions, AKA Sojourn. This information can include: your IP address, browser type, domain names, access times and referring website addresses. Use of Cookies

- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another customer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.
